NITRO CITY COUNCIL MEETING MINUTES TUESDAY, MARCH 6, 2012

CALL TO ORDER: Mayor Rusty Casto called the meeting to order at 7:00 pm in Council Chambers. Attending were Recorder Rita Cox, Ward 1 Councilman A. A. "Joe" Savilla, Ward 2 Councilman Bill Racer, Ward 4 Councilman Bill Javins, Councilmen at Large Dave Casebolt, Bob Fields, and Jim McKay, City Treasurer John Young and City Attorney Richie Robb. Ward 3 Councilman Craig Matthews was absent.

INVOCATION/PLEDGE OF ALLEGIANCE: The Invocation was given by Councilman A. A. "Joe" Savilla and the Pledge of Allegiance was led by Chris Walters.

APPROVAL OF COUNCIL MINUTES: RECORDER RITA COX MOVED THE MINUTES OF THE FEBRUARY 7 MEETING OF COUNCIL BE APPROVED WITH A SECOND BY COUNCILMAN BOB FIELDS. VOTE WAS UNANIMOUS FOR THE MOTION TO CARRY.

FUTURE DATES OF COUNCIL: Mayor Rusty Casto said the future dates of Council are March 20 and April 3 and 17.
